#### FC/143 REGULAR REVIEW OF FINANCIAL DOCUMENTS AND REPORTS

- Cil reports -The Clerk gave a brief update on the latest CIL position as regards expenditure and reported that there had been no income received in April 24.
- It was also agreed that the Clerk should look at options for new accounts and or transferring money to the higher interest deposit saving accounts.

### FC/144 TO REVIEW AND AMEND THE NEW MODEL FINANCE REGULATIONS FROM NALC FOR RECOMMENDATION TO FULL COUNCIL

 Having previously been circulated to Councillors and taken as read, the Clerk presented a " marked up" copy to Cllrs which was then gone through by the committee paying attention to the sections which had been amended or which required a choice on available wording or thresholds. It was noted by the Clerk that this was a much changed version of the Finance Regs, having been reviewed and updated substantially. It was further noted that the new version appeared more up to date , for example with more detail regarding online banking and direct debits and less on cheques and cash.

• Any necessary amendments having been made and agreed, it was RESOLVED to recommend this amended version to the next full council

## FC/145 TO REVIEW THE INVESTMENT STRATEGY

• Having been previously circulated and taken as read, the Investment Strategy was readopted for the current year. It was noted that having completed the recent Cil works at the recreation ground, the council now had less in reserves, however it was also noted that high interest rate conditions meant there were options for the savings accounts.
