#### Part 1

##### Interments

The fees indicated for the various heads of items 1 and 2 do not include the digging of the grave, which is deemed to be the responsibility of the funeral director or his agent.

	PARISH	NON - PARISH
1. For any interments in any grave	£210.00	£1,750.00
2. For the interment of cremated remains in a grave in respect of which exclusive right of burial has been granted	£125.00	£1,050.00

NB There shall be no interment charges for babies and children under the age of five years. If the plot is subsequently used for non-exempt interments, the above interment fees will apply.

#### Part 2

##### Exclusive Rights of burial in Earthen Graves:

1. For the exclusive right of burial in an earthen grave 9 feet by 4 feet	£420.00	£3,500.00
2. For the exclusive right of burial for cremated remains in an earthen grave 2 feet by 2 feet	£210.00	£1,750.00

##### Memorials, Gravestones, Tablets & Inscriptions:

For the right to erect or place on a grave in respect of which the exclusive right of burial has been granted:

Additional inscription on any memorial		£35.00	£70.00

NB:

- All Non-Parish fees – Part 1, Part 2 and Part 3 are reduced by 20% for residents of adjoining parishes which do not have their own cemetery.
- For residents who already have existing connections with the cemetery (existing plots, other family members, pre-purchased graves), a 50% discount on out-of-parish fees can be charged.
- For those who have previously been resident in the village for 25 years or more AND have been non-resident for 5 years or fewer (ie, due to ill health, etc), local rates can be charged.

Fees for the searches of registers together with copies and extracts are governed by Section 8 of the Burial Act of 1953.
